### 'TOY STORY 4' STUNTMAN DIDN'T INFRINGE EVEL KNieVEL TRADEMARKS

U.S. District Court for the District of Nevada's Judge James C. Mahan dismissed K&K Promotions Inc's claim for trademark infringement against Disney in relation to Pixar's movie "Toy Story 4" which was alleged to be similar to a Candian character known as Duke Caboom. Among others, the Court found there was a lack of likelihood of confusion amongst consumers.

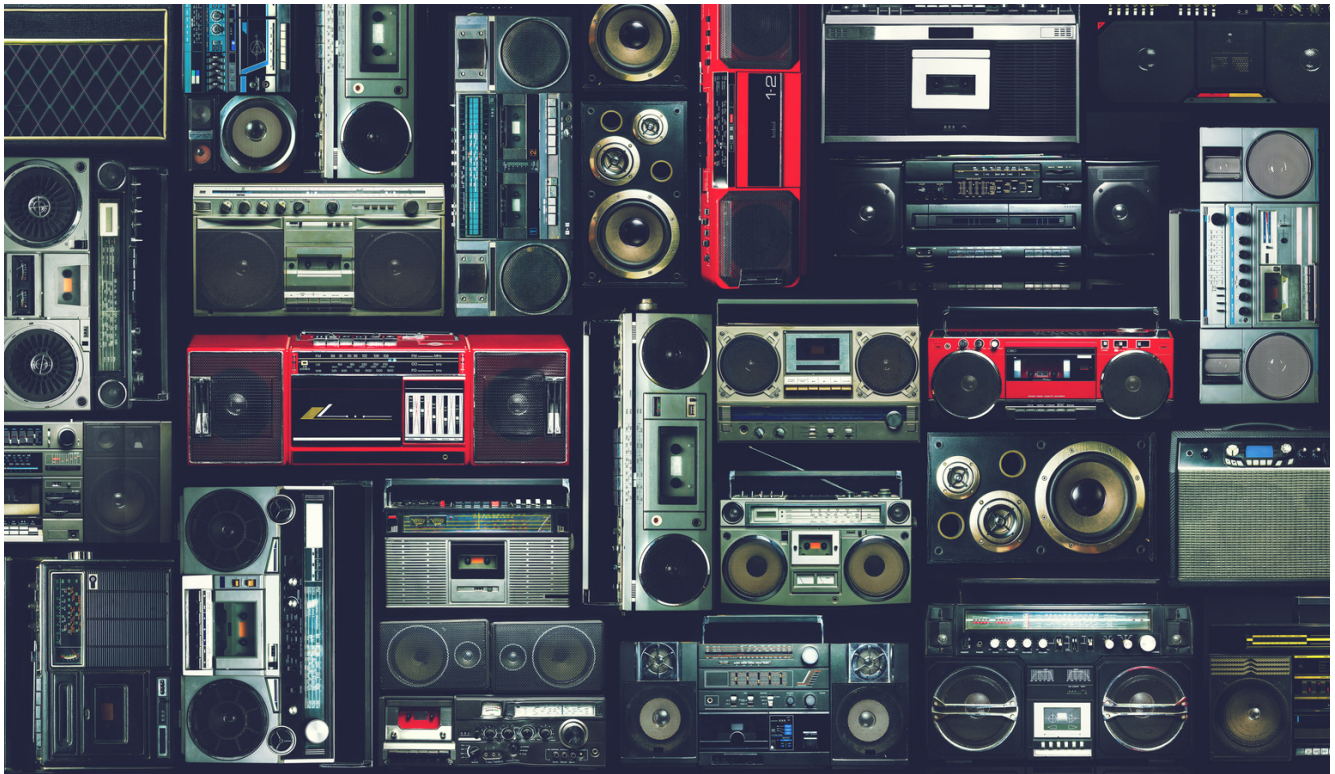

### ALLEGED TRADEMARK INFRINGEMENT: COURT VACATES EX-PARTE ORDER AGAINST NBC

In Nigeria, Rite Foods accused the Nigerian Bottling Company of trademark infringement over its “Fearless” energy drink. The Judge of the Federal Court in Lagos dismissed a previously granted interim injunction order restraining the latter company from promoting its alleged infringing product to “avoid confusion” as there is a pending suit to determine the Plaintiff’s application for an interlocutory injunction before another judge.

### CHINA LIMITS GAMING TIME FOR UNDER-18S TO ONE HOUR A DAY ON FRIDAYS, SATURDAYS, SUNDAYS AND PUBLIC HOLIDAYS
