**Integrity in the Banking Industry — Submitting a False Claim**

*Nur Naima Binti Nahayadin v Malaysia Building Society Berhad*  
(Industrial Court Award No 2434 of 2018)

The claimant, an Account Relationship Manager, attended an event that was organised by the Company and held out of town. She travelled together with a colleague, who had driven his own car to the event. The claimant had lent her car to another colleague who also attended the event.

According to the Company's policy and procedure, if there is more than one employee travelling together, only the one driving the car can make the mileage claim. In spite of this, the claimant submitted a mileage claim and tried to justify it by saying that her superior had given her the approval to do so.

The Industrial Court dismissed her claim for unlawful dismissal and held that:

- (a) The travel claim submitted by the claimant was a false claim, made with intent to deceive the management of the Company and it amounted to a dishonest act; and
- (b) The claimant had broken the trust placed in her by the Company, making the penalty of dismissal a reasonable punishment made with just cause or excuse that was commensurate with the wrongdoing of the claimant.
