YA Datuk Noorin bt Badaruddin

Judge, High Court

Justice Datuk Noorin Badaruddin is a Judge of the High Court of Malaya in Kuala Lumpur. She hails from Taiping, a small town in the State of Perak Darul Ridzwan. She pursued her tertiary education at the International Islamic University of Malaysia (IIUM), graduating in 1990 with a Bachelor of Laws, LLB (Hons), and later obtained a Masters of Law, LLM (Hons), from the University of Wollongong, Australia.

Justice Noorin is the first female graduate from IIUM to be appointed as a Judicial Commissioner and later as a High Court Judge of Malaya. Before joining the judiciary, she served as a legal officer at the Attorney-General's Chambers, Malaysia. She held the position of Federal Counsel at the Insolvency Department of Malaysia, and from 1997 until her appointment as a Judicial Commissioner of the High Court of Malaya in 2014, she served as a Deputy Public Prosecutor in both the Prosecution Division and the Appellate and Trial Division. During her tenure in the Appellate and Trial Division, she headed the Trial Unit, managing high-profile cases. Her last position at the Attorney-General's Chambers was as Deputy Head of the Prosecution Division, overseeing the policy sector.

Justice Noorin was appointed as a Judicial Commissioner in 2014 and as a Judge of the High Court of Malaya in February 2017. She has served in the High Courts of Ipoh and Kuala Lumpur (Commercial Division); the Shah Alam High Court (Criminal Division); and the Kuala Lumpur High Court (Special Powers Division and Criminal Division).

Devkumar was called to the Honourable Society of Lincoln's Inn, England in October 2000, admitted as an Advocate & Solicitor in Malaysia in August 2001 and is a Managing Partner in Kumar & Co with 22 years of experience. In addition, he advises on areas of Legal Tech, Cyber Security, Data Protection, Artificial Intelligence and all legal aspects of the Tech Industry. Devkumar has been undertaking criminal trials from the Magistrates courts up to the High courts throughout Peninsula Malaysia mainly defending in the areas of murder, drug trafficking, kidnapping, manslaughter, assault, robbery, fraud and criminal breach of trust to name a few.

He has extensive appellate experience in these fields to the Federal Court. He was the Secretary of the Penang Bar Committee from 2007-2008 and 2009-2013 and was Chairman of the Welfare and Pupil Affairs Sub-committee. He is currently the Chairman of the Continuing Professional Development Committee in the Penang Bar from 2019-2023, Chairman of the Legaltech Committee 2021-2023 and a member of the Criminal Law Committee of the Bar Council from 2009-2013 and 2019-2023. He has also been a certified Advocacy Trainer for the Bar Council since 2016. He has been training pupils and lawyers in all aspects of trials and appeals around Criminal and Litigation throughout Malaysia.

Dr. Haezreena is a Criminologist and the Deputy Dean for Higher Degree at the Faculty of Law, University of Malaya. She holds an LLB (Hons) from the International Islamic University Malaysia (IIUM), an LLM in International Human Rights Law from the University of Leicester, UK, and a PhD in Criminology from Victoria University of Wellington, New Zealand. She was admitted to the Malaysian Bar as an Advocate & Solicitor in 1997 and practiced law for 21 years before transitioning into academia.

Throughout her career, she has conducted extensive research on human trafficking, gender, incarceration and prisons, terrorism and violent extremism, sexual violence, and victimisation. Dr. Haezreena takes a hands-on approach by working directly with prisoners, victims of trafficking, and ex-militants. She is frequently sought by law enforcers, government officials, civil society organizations (CSOs), and the media for her expert opinion on crime, gender, human trafficking, and terrorism.

She has published books, book chapters, and articles, and has presented papers at various local and international conferences on these topics. Her work has been highly praised by international scholars for its originality and novelty, and it is often cited in academic journals, reports, and media outlets.

Latheefa was called to the Malaysian Bar in 2001 and has been actively involved in numerous public interest and human rights cases and initiatives for several years. She is currently a partner at Messrs Daim & Gamany, a leading public interest law firm based in Kuala Lumpur, Malaysia.

In 2011, she co-founded Lawyers for Liberty, where she now serves as one of its Advisors. Lawyers for Liberty is a human rights and law reform initiative that challenges unconstitutional, arbitrary, and unreasonable decisions and act perpetrated by the government, its agencies, and other public authorities.

Latheefa has been involved in various initiatives, including the Bar Council's Legal Aid Centre, the Refugees and Migrants Clinic, the Immigration Law Reform Committee, Suara Rakyat Malaysia (Suaram), and the Gerakan Mansuhkan ISA (Abolish ISA Movement). She also served as Chief Commissioner of the Malaysian Anti-Corruption Commission (MACC) from 4 June 2019 to 9 March 2020.
